The following orders are issued with the approval of the competent authority:

1. Sri Ch. Papa Rao, Gr. 'B' (Adhoc), ADEN/SW/DHNE (PC: 03SC8W070) is transferred to Guntur Division and is posted as ADEN/Br./GNT (PC: 03SC8W073) against an existing vacancy on his own request.
2. Sri T. V. S. Narasimha Rao, SSE/P.Way/GTL who is medically found fit for Group 'B' Technical vide CMS/GTL's certificate No. 20/2023/GAZ dated 30.06.2023 is promoted as Adhoc ADEN and is posted as ADEN/SW/DHNE (PC: 03SC8W070) vice Sri Ch. Papa Rao, SI. No. 1 above.


The promotion of Sri T.V.S. Narasimha Rao, SSE/P.Way/GTL to Group 'B' post on adhoc basis is subject to the following conditions:

- i) The adhoc promotion is purely temporary till the formation of regular Group B panel.
- ii) The adhoc promotion does not confer the employee any right of continuity, seniority or any other consequential benefits except those which are specifically allowed in terms of extant instructions. The adhoc arrangement can be terminated at any time without assigning any reasons.
- iii) The continuation of the SSE as adhoc ADEN/AXEN would be subject to his performance in the post and in case performance of the SSE is found to be unsatisfactory, he will be reverted back to the parent post without assigning any reason there for in terms of Para 208.2 of IREM Vol-I.

The promotion is subject to the SSE being free from DAR/SPE/Vigilance cases and that he is not presently undergoing any penalty that debars promotion.

Sri T.V.S. Narasimha Rao, SSE/P.Way/GTL is eligible for fixation of pay under Rule 1313 (FR 22) (i) (a)(1) of IREC Vol-I and Railway Board's instructions contained in RBE No. 212/2019 (SC No. 01/2020). In case the employee is in Pay Level-8 due to grant of MACPS, no further fixation is allowed on his promotion as per extant instructions.

The date the above changes take place should be advised duly sending charge assumption/relinquishment reports to all concerned and in triplicate to Dy. CPO/Gaz.
