Sub:- Gazetted Arrangements – Civil Engineering Department.

The following orders are issued with the approval of the competent authority:


6. Sri G. Srinivas Hanumaiah, SSE/P. Way/Con/SC, who is medically found fit for Gr. 'B' Technical vide CMS/KZJ's certificate No. A-II/460/22 dated 31.01.2023 is promoted as adhoc ADEN and is posted as AXEN/C/KMT (PC: 03SC8W080) against an existing vacancy.
7. Sri A. Kanaka Durga Rao, SSE/Works/HQ, who is medically found fit for Gr. 'B' Technical vide MD/LGD's certificate No. 0386/02.02.2023 dated 02.02.2023 is promoted as adhoc ADEN and is posted as AXEN/GS/GTL (PC: 03SC8W089), vice Sri Y. Ramana Rao, Sl. No. I (1) above

The postings of employees mentioned at Sl. Nos. 1 to 7 of Para-II are subject to the following terms and conditions:

- i) The adhoc promotion is purely temporary till the formation of regular Group B panel.
- ii) The adhoc promotion does not confer the employee any right of continuity, seniority or any other consequential benefits except those which are specifically allowed in terms of extant instructions. The adhoc arrangement can be terminated at any time without assigning any reasons.
- iii) The continuation of the SSEs as adhoc ADEN/AXEN would be subject to their performance in the post and in case performance of the SSE is found to be unsatisfactory, he will be reverted back to the parent post without assigning any reason there for in terms of Para 208.2 of IREM Vol-I.
- iv) The promotion is subject to the SSE being free from DAR/SPE/Vigilance cases and that he is not presently undergoing any penalty that debars promotion.

The employees on their adhoc promotion to Gr. 'B' are eligible to exercise option for fixation of pay in promotional grade within a period of one month from the date of their promotion in terms of instructions contained in Para 1313 (FR 22) (i) (a) (1) of IREC Vol-I and RBE No. 212/19 (SC No. 01/2020). In case those employees who are already in Level-8 & 9 due to grant of MACPS, no further fixation is allowed on their promotion as per extant instructions.

The date the above changes take place should be advised duly sending charge assumption/relinquishment reports to all concerned and in triplicate to Dy. CPO/Gaz.
