Further to this office Notification dated 04.11.2024 for filling up of **7 (UR-5; SC-1 & ST-1)** vacancies, the lists consisting 127 (one hundred and twenty seven only) eligible employees and 2 (two only) ineligible employees for the selection to the Group 'B' post of Assistant Material Manager against 70% selection quota for the vacancy cycle 01.01.2025 - 31.12.2026 are enclosed herewith as **Annexure**– **A & B** respectively.

All the controlling officials are advised to note and notify to all the eligible/ineligible employees working under their control and advise the eligible employees to be in readiness to appear for Written Examination in the form of <u>Centralized Computer Based Test (Objective type)</u> to be conducted by DG/NAIR on 9th March 2025.

Pre-Selection Coaching to all the eligible employees belonging to the 'SC' & 'ST' community will be arranged by Dy.CMM/IC & Secy. to PCMM for a period of 60 hours should be spread over to 15-20 working days (3-4 weeks) in terms of RBE No. 142/2019 and Railway Board's letter No. E(GP)2022/2/4 dated 18.10.2022. The Venue and duration of coaching classes will be intimated by Dy.CMM/IC & Secy. to PCMM in due course. In case any candidate is unwilling to undergo pre-promotional coaching, a written declaration of unwillingness (unconditional) to attend the pre-selection coaching classes should be obtained from him/her and sent to Dy.CMM/IC & Secy. to PCMM who in turn will forward the same in one bunch to this office for record after completion of the pre-selection coaching classes. In case any eligible 'SC' & 'ST' reserved employee fails to attend the pre-promotional training on the specified dates, no separate pre-selection coaching will be held and they will have to appear for the written test without such pre-promotional training.

If any of the employees mentioned in the eligibility list (Annexure 'A') are on leave/training/deputation/sick or working in any other unit, intimation should be sent to their place of working/personal address with an acknowledgment and the copy of the same shall be forwarded to this office for record.

The Syllabus as well as the distribution of marks for the Written Examination (CBT) were already advised in this office Notification dated 04.11.2024. As already mentioned in the Notification, the written examination through the Centralized Computer Based Test shall comprise of 100 marks consisting of 100% objective type multiple choice questions only. The question paper will contain 110 questions that include 10 questions on Raj Bhasha which are optional. The duration of the written examination will be **Two hours**. In terms of Railway Board's letter No. E(GP)2024/2/28 dated 08.10.2024 (RBE No. 93/2024), there shall be no negative marking in written examinations held as part of Selections (70%) where the final panels are made on seniority basis.

The exact time and venue(s) of the examination together with any other instructions related to the written examination through CBT will be intimated shortly.

None of the eligible PwBD employees are not eligible for the compensatory time/scribe.

The eligible employees are once again advised to verify their HRMS ID, which is a primary key to download their E-call letter for the CBT and if, any corrections are required the same may be brought to the notice of the Dealing clerk on Railway Phone No. 86855.
