In terms of Para 305 & 306 of IREM Vol.I Chapter-III it is mentioned that:

<u>Para-305:</u> When, however, a candidate whose seniority is to be determined under paragraphs

303 and 304 cannot join duty within a responsible time after the receipt of orders of appointment, the appointing authority may determine his seniority by placing him below all the candidates selected at the same examination/selection, who have joined within the period allowed for reporting to duty or even below candidates selected at subsequent examination/selection who have joined before him.

<u>Para-306</u>: Candidates selected for appointment at an earlier selection shall be senior to those selected later irrespective of the dates of posting except in the case covered by paragraph 305 above.

In terms of Para 306 of IREM-I, Sri K.Sreekanth appointed at an earlier selection i.e, CENNo.01/2012 shall be senior to those selected later irrespective of the dates of posting i.e, against of CEN No.01/2015.

Therefore, it is proposed to revised the seniority of Sri K.Sreekanth in the cadre of SSE/P.Way in Level-7 before Smt. Bayyarapu Geeta Sahithi who was selected against CEN No.01/2015 and topper in the merit list as published by Principal/ZCETI on 25.04.2018.
