The following orders are issued with the approval of the competent authority:

In terms of Railway Board's letters No. 2024/E(GR)I/38/1 dated 29.08.2024 & 08.11.2024 and in accordance to this office web Notifications dated 17.10.2024 & 27.11.2024, for the re-engagement of retired Railway officers as Consultant/Electrical on monthly remuneration basis, the following Electrical officers who have volunteered for the reengagement as Consultant/Electrical and found fit in requisite medical examination are re-engaged as Consultant/Electrical on monthly remuneration basis and are posted as detailed below:

- 1) Sri T.V.Dikshitulu (DOB:11.06.1963), Retired Sr.DEE/M/MAS, PPO No. 20237060200306 is reengaged as Consultant/Electrical and is posted as Consultant/Electrical/RYPs against the post of ADEE/RYPs (PC: 04SC8W010).
- 2) Sri S. Srinivasa Rao (DOB: 08.05.1961), Retired ADEE/M/BZA, PPO No. 20217090700190 is reengaged as Consultant/Electrical and is posted as Consultant/Electrical/M/KZJ against the post of ADEE/M/KZJ (PC: 04SC8P001).
- 3) Sri B. Srinivasa Rao, (DOB:05.06.1963), Retired ADEE/TRD/BZA, PPO No. 20237090700185 is reengaged as Consultant/Electrical and is posted as Consultant/Electrical/C/BZA against the post of ADEE/C/BZA (PC: 04SC8W004).

- 4) Sri C.S Vijaya Kumar (DOB:11.03.1963), Retired ADEE/TRD/DKJ, PPO No. 20237090500093 is reengaged as Consultant/Electrical and is posted as Consultant/Electrical/TRD/HQ against the post of AEEE/TRD/HQ (PC: 04SC8P022).
- 5) Sri B. Subba Rao (DOB: 04.06.1962), Retired AEEE/RE/SC, PPO No. 20227090100082 is reengaged as Consultant/Electrical and is posted as Consultant/Electrical/GSU/SC against the post of ADEE/GSU/SC (PC: 04SC8P005) mentioned at Sl. No.I(1) above.
- 6) Sri Ashfaq Hussain (DOB: 16.11.1963), Retired ADEE/M/SC, PPO No. 20237090500404 is reengaged as Consultant/Electrical and is posted as Consultant/Electrical/S/LGD against the vacant post of ADEE/S/LGD (PC: 04SC8P004).

The reengagement of the retired officers mentioned at para-II is subject to execution of agreement for the reengagement in person at Headquarters office and also subject to the following terms and conditions:


- i. The engagement of Consultant shall not be considered as a case of re-employment.
- ii. Period of engagement shall be initially for a period of one year or till attaining the age of 65 years or further extension as per requirement up to 31.12.2026 whichever is earlier.
- iii. Re-engaged officer shall be discharged immediately on joining of selected candidate(s)/employee(s) from UPSC or departmental selection(s) respectively or as per the recommendations of PHOD/CHOD concerned.
- iv. A fixed monthly remuneration shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged from the term of the contract. Annual increment/ percentage increment and dearness allowance shall not be allowed during the contract period.
- v. Re-engaged officer shall not be entitled for HRA, Residential accommodation. However, Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. When required to travel in connection with official works, TA/DA may be allowed as per their entitlement at the time of retirement.
- vi. Detailed day to day duty list shall be prepared by respective Controlling Officer and the re-engaged officer shall work under the guidance and command of assigned Controlling Officer.
- vii. The consultant shall not divulge any information gathered by him during the period of assignment related to the organization to anyone who is not authorized to know/have the same.
- viii. The consultant will not be made in charge of the unit like Branch Officer in the Division or independent in charge in the Construction Unit.
- ix. Re-engaged officer shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate.
- x. The Administration has the right to transfer re-engaged officers within jurisdiction of SCR in administrative exigencies.
- xi. The Administration is at liberty to terminate the services of the re-engaged officer in case of his work/conduct is found unsatisfactory.
- xii. The re-engaged officer will have to give 7 days' notice for discontinuing the service.

- xiii. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed nor carried forward in case of the engagement is extended. Also, no payment in lieu of unutilized leaves will be paid at the time of discharge/expiry of the contract. Re-engaged officer shall be on duty on normal duty hours followed by the office in which he will be posted. The duty hours can be changed as per the requirement of work by the administration. He will be eligible for weekly off and General Holidays observed by the office in which he will be posted.
- xiv. The re-engaged retired officer will be responsible for filing of tax liabilities in respect of remuneration paid to them by Railways for above re-engagement.

The date the above changes take place should be advised duly sending charge assumption/relinquishment reports to all concerned and in triplicate to Dy.CPO/Gaz.


