
The adhoc promotions of employees mentioned at para (II) above are subject to the following terms and conditions:

- i) The adhoc promotion is purely temporary till the formation of regular Group 'B' panel.
- ii) The adhoc promotion to employees do not confer any right of continuity, seniority or any other consequential benefits except those which are specifically allowed in terms of extant instructions. The adhoc arrangement can be terminated at any time without assigning any reasons.
- iii) Their continuation as adhoc AXEN/ADEN would be subject to their performance in the post and in case of their performance is found to be unsatisfactory; they will be reverted back to their parent post without assigning any reasons there for in terms of Para 208.2 of IREM Vol-I.
- iv) The above promotions are subject to the employees being free from DAR/SPE/Vigilance cases and that they are not presently undergoing any penalty that debars them for promotion.

The employees on their adhoc promotion to Group 'B' are eligible to exercise option for fixation of pay in promotional grade within a period of one month from the date of their promotion in terms of instructions contained in Para 1313 (FR 22)(i)(a)(1) of IREC Vol-I and RBE No. 212/19 (SC No. 01/2020). If, the employees are already drawing higher level of pay in Level-8 and above due to grant of MACPS, no further fixation is allowed on their promotion as per extant instructions.

The date the above changes take place should be advised duly sending charge assumption/relinquishment reports to all concerned and in triplicate to Dy.CPO/Gaz.


