The following orders are issued with the approval of Competent Authority.



- 2) Smt. M. Rama Kumari, PS-II, PCME/O/SC, who is empanelled for promotion to Gr. 'B' post of Private Secretary Gr. I/Gaz in Level-8 of 7<sup>th</sup> CPC Pay Matrix vide Panel No. 423 dated 18.11.2024, is promoted to Group 'B' Service and is posted as Private Secretary Gr.I/Gaz to DRM/GTL against post mentioned at SI. No. 1 above.

Smt. M. Rama Kumari, PS-II, PCME/O/SC will be on probation for a period of 12 months in terms of Para 13, Section-F, Chapter-I of IREM Vol-I. The appointing authority will, on completion of the period of probation will assess the work of the officer and if considers that the same is not satisfactory, the officer can be reverted or the period of probation can be extended.

Smt. M. Rama Kumari, PS-II, PCME/O/SC is eligible to exercise option for fixation of pay in promotional grade within a period of one month from the date of her promotion in terms of provisions contained in Rule 13(3)(FR 22) I (a) (1) of IREC Vol-II and instructions contained in RBE No. 212/2019. However, if the employee is already in higher Pay Level of Level-8 and above due to grant of MACP, no further fixation of pay is allowed as per extant instructions.

The promotion of the above employee is subject to the condition that she is free from DAR/SPE/Vigilance cases and that she is not undergoing any penalty effecting Pay in the existing level as on the date of her promotion.


