Sub:- Administrative Grade arrangements – Civil Engineering Department.

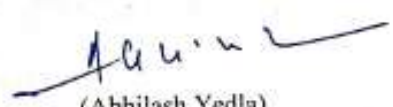
The following orders are issued with the approval of the competent authority:

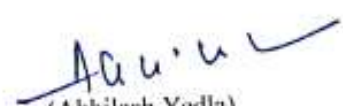
