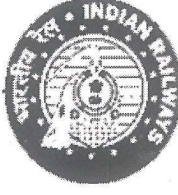
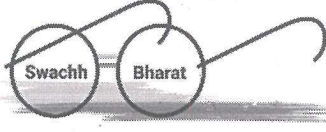

The period from 08.07.2025 till date is to be treated as waiting for orders in favour of Sri Marampudi Vamsikanth, SG/IRSME.




