In response to this office notification to fill up **sixteen** posts (**UR- 14,SC-02**) of Chief Loco Inspector (Electrical Traction) in Pay Band-2 Rs.9300-34800 with Grade pay of Rs.4600/-, a total of 311 applications have been received in this office duly forwarded by Sr DEE/TRSO/SC (302 appl.) & Sr DME(O&F)/SC (09 appl.) within the cut off date i.e,11-01-2016 and the same have been scrutinized and the final eligible and in-eligible list is prepared strictly adhering to the terms and conditions applicable for the said selection.

The list of 301 eligible applicants is enclosed as Annexure "A" and the list of 10 in-eligible applicants is enclosed as Annexure "B" duly indicating the reasons for declaring them in-eligible.

The selection will be finalised based on the written examination only as per the instructions issued by Rly brd vide Lr No E(NG) I/2000/PM1/41 dated 07.09.2003 and final panel will be drawn based on merit..The written examination will be held at short notice, the date and the venue of written examination will be notified in due course.

In terms of Rly Brd's instructions circulated by CPO/SC vide S.C. No 163/86 applicants belonging to SC/ST are to be imparted with Pre-Promotional Training . Hence, **Sr.DEE/TRS/SC and Sr.DME/O&F/SC** are requested to organise pre-selection coaching to the eligible SC/ST employees and issue a certificate to that effect immediately after completion of the same. The coaching must cover the syllabus for the examination. The pre-selection coaching may be organised for a period of 3 to 4 weeks. The question bank is available on www.scr.indianrailways.gov.in.

Names mentioned at Sl nos: 33,261,298 and 300 in the eligibility list enclosed as Annexure 'A' are provisionally made eligible since they worked/ working as CCs/TLC as the case may be and they should acquire 75,000/- KMs on the event of their selection before being deployed as Chief Loco Inspector(Electrical Traction). Further, the eligibility list is not as per seniority order.

All the depot in-charges should note and notify the eligible staff alerted vide Annexure "A" to be in readiness for the written examination duly taking their acknowledgement . The syllabus for the selection will be circulated in due course.

Staff on sick/leave should also be intimated to their sick/leave address and obtain their acknowledgement.


