

**COMMERCIAL CIRCULAR No. 117 OF 2018**  
**Draft Notification for TRC No.5 of 2018**  
**(GOODS)**

Sub: - Exemption from Payment of Wagon Demand Registration Fee.  
Ref: - Commercial Circular No. 161 of 2017.

**Authority:** Railway Boards Freight Marketing Circular No.15 of 2015.

1. Para 3 of Freight Marketing Circular No.15 of 2015 stipulates that the earnings criteria for reckoning the different type/category of 'Premier Customers' as Platinum, Gold and Silver card holders shall be as under:
  - i) Outward Traffic booking from 'Sidings' alone will form the criteria for classifying the premier customers.
  - ii) "Only outward traffic" from "sidings" will be eligible for reckoning the category under which the siding falls.
  - iii) The loading of any outward traffic in the sidings has to be "Paid Traffic".
  - iv) Parties having multiple sidings on a single Railway shall be classified on the basis of originating earnings of each siding separately. No clubbing of originating earnings for each of the siding each envisaged under this scheme.
2. Board has also advised that Zonal Railways shall complete a list after an annual review of Platinum, Gold and Silver card holders of their Railways and publish the same, under intimation to Boards office. The list shall be updated by the Zonal Railways for each financial year.
3. The "Premier Customers" shall be exempted from the requirement from the payment of Wagon Registration Fee (WRF) for the wagons / Rakes indented by them.
4. Board vide RC No. 02/2007(CC NO. 17 of 2007) advised that w.e.f. 25.1.2007, an amount equal to wagon Registration Fee may be collected from Premier Customers who have been exempted from payment of Wagon Registration Fee, if they cancel their indents under any circumstances notified in Rule No. 201 (15) of Goods Tariff NO.41 (Part I) Vol.I.
5. In this regard, in supersession of Commercial Circular No. 161 of 2017 and it's addendas, the list of sidings/co-users/individual customers categorized as Platinum, Gold and Silver card holders for 2018-19, (based on the originating traffic earnings for the year 2017-18) for the purpose of exemption of wagon Registration Fee is given below :
