PCPO/SC vide Lr.No. P[R] 605/XV, Dt. 29.11.2023/05.12.2023 has issued the following instructions/guidelines in regard to publishing of key and with respect to the objection tracker system in objective type written examinations in departmental selections.

- (i) The key given by the respective paper setting authority will be published in the website along with the list of aspirants who have attended the examination.
- (ii) The aspirants of the corresponding examination will be given only 7 days (incl. intervening holidays) from the day next to date of publishing of key in website to make a written representation i.e., objections with regard to incorrect answers published in key and ambiguity in questions to their respective personnel branch officer, through their controlling officer.
- (iii) No extension of time will be given under any circumstances for the exercise as mentioned above.
- (iv) While raising the objection, the aspirant should invariably enclose relevant authority/document substantiating the claim, without which the representation/objection will not be entertained.
- (v) The decision of the paper setting authority will be final and no further correspondence in this regard will be entertained.
- (vi) The final key along with the decision taken on the representations received will be published in the website.

Accordingly, the key given by the respective paper setting authority is herewith publishing in website for information and for further course of action as detailed above in the subject selection.
