Samata Andolan Samithi through president Vs Sanjay Kothari and Ors) and any other cases/directions pending in any other courts, and also provisional subject to reversion based on the final outcome of the above court cases and any other cases /directions issued from time to time.

The above promotions are provisional and subject to the final outcome of ongoing litigations/Court cases in the matter of Jarnail Singh and Others Vs Laxmi Narain Gupta SLP (Civil) No.30621 of 2011.

They will be placed on probation for a period of two years. Promotions will be subject to all the rules and regulations issued by the Government of India and S.C. Railway Administration from time to time.

The date of shouldering higher responsibilities may be advised to all concerned.
