Grievances not connected to the settlement dues and cases involving purely legal points e.g. succession certificate etc., cannot be taken up in the Pension Adalat. Grievance once redressed through earlier pension adalats need not be represented again.

The last date for receipt of the grievances in this office is 5th November 2024. Please note that it may not be possible to deal with grievances received after due date.
