Please connect this office notification dated 7.11.2023 on the above subject wherein it was mentioned that the candidates qualified in the written examination shall be subject to fitness in the medical standard in B-1 classification, those found fit in B-1 will only considered for next stage of selection process. Supervisory staff of Mechanical Department of Open line and workshops have been categorised as Safety category as per Rly Board's letter circulated under RBE No. 02/2020, dated 06.01.2020.

As there is no mention about medical classification in the said Railway Board letter and other subsequent letters, HQRS has been requested to advice on the medical fitness required for empanelment of the candidates vide this office letters dated 28.03.2024, 15.04.2024 & 19.08.2024. PCPO/SC has advised vide PCPO/SC ltr No.SCR/P-HQ/210(a)/EM/CWE RYPS/Med Dt 13.09.2024 that a reference has been made to Railway Board on 24.04.2024 and the reply is still awaited from Board and that a reminder has also been sent.

It was further advised that, in the meantime, to process the selection of JE/Mech with the present 'CEE ONE' medical classification.

In view of the above, it is hereby advised to all concerned that fit in CEE-ONE medical classification will be considered for next stage of selection. Accordingly, the fitness of medical classification stipulated in the notification dated.07.11.2023 from higher B-1 to lower medical classification of CEE-ONE stands reduced.

All the candidates are advised to take note as above.
