**Traction Loco/Power/Crew Controller Notification**  
**Last date to submit application by volunteers is 11.11.2024**

**Sub:** Filling up/drafting of posts of Traction Loco Controller (TLC)/Power Controller (PC)/Crew Controller (CC) in Diesel & Traction in Electrical (Running) Department of BZA Division on tenure basis.

01. It is proposed to fill up the following posts in Diesel & Traction in Electrical (Running) Department of BZA Division on tenure basis by calling volunteers.

**2.0 Eligible staff :**

- 2.1 Loco Pilot (Goods/ Passenger/ Mail) who have completed 75,000 kilometres of actual driving experience in terms of CPO/SC No.52/2009. **The tenure of such suitable LP (Goods/Passenger/Mail) who are drafted and posted to perform the duties will be three years.** The employees already worked as TLC/PRC/CC are to be followed the **cooling off period of Three years.**
- 2.2 Medically decategorised Loco-pilots up to A-3 medical classification will be eligible to be drafted to perform the duties of Traction Loco Controllers /Power Controller /Crew Controllers in their case, the tenure rules of under Para (1) above will not be applicable. However, if the performance is not found satisfactory, in addition to action under D&AR. As they cannot go back to Running duties, they will be considered for alternative employment as is applicable to medically decategorised employees. In the event of selection of medically decategorised employees as CC/TLC/PRC, they are NOT eligible for any allowances pertain to running staff.

**3.0 Tenure:** Three years. The employees already worked as TLC/PRC/CC are to be followed the **cooling off period of 03 years.**

- 4.0 The eligible employees will be subjected to Screening Test (oral) and those who are found suitable in the Screening Test will be posted as TLC/PC/CC over BZA Division. **SENIORITY WILL NOT BE THE CRITERIA FOR THE ABOVE SELECTION.** No Supplementary Screening Test will be conducted as the selection is conducted by calling volunteers. As such, all the eligible volunteers must attend the Screening Test (oral) without fail on the date of screening, which will be advised later.

5.0 The lien and seniority of the staff so drafted will be maintained in parent cadre and will continue to progress in the running cadre (except medically decategorized employees) and will be governed by all the terms and conditions of service applicable to running staff including pay and allowances, selections, suitability tests and prescribed medical examinations. The selected Loco Pilots are eligible for payment of allowance in lieu of kilometerage at the rates applicable to them. Except this, they are not entitled for any other allowances.

**6.0 Submission of applications:**

- 6.1 The eligible staff who are willing to volunteer for the above selection may apply in the enclosed Performa (Annexure-A) and submit the same to respective Supervisor (CCC) on or before 11.11.2024. The Controlling supervisor has to verify and certify the Kilometers earned by each of the volunteered employee before forwarding the applications. If it is found at a later date that the certification done by the supervisory official is incorrect, DAR action will be initiated.
- 6.2 The Supervisor (CCC) should sent all the applications in one bunch to Controlling Officer on or before 18.11.2024.
- 6.3 The Controlling Officer to certify that they have 75,000 kms of actual driving experience along with DAR/SPE/Vig., clearance, duly countersigned, should be forwarded to APO/Mech/BZA in one bunch in hard and soft copy, under covering letter with details of driving experience of each employee on or before 25.11.2024.
- 7.0 This notification may be given wide publicity duly placing it on the Notice Board for the information of the employees working in your Depots. The notification is also available on SCR website i.e. [www.scr.indianrailways.gov.in](http://www.scr.indianrailways.gov.in).
