I) The following Loco Pilots(Goods) in scale Rs.930-34800+4200 GP were transferred and posted to the stations mentioned against each on their same pay and scale on their own request. **They are not eligible for any transfer benefits.**

Therefore, these 3 employees should be allowed to take higher responsibilities with effect from the date of issue of competency certificate. Item no.13 has failed in the training and hence he is not eligible for promotion.**

**All the above employees, who are promoted and transferred to other stations are eligible for transfer benefits.**

III)The employees, who are transferred to other stations, should be relieved immediately to carry out the transfer orders. They should vacate the Rly.Quarter, if in occupation, before carrying the transfer orders. Supervisory officials are responsible to relive the employees and advise this office about the date of relief and joining of the employees.

IV)The above promotions are subject to :-

1. Outcome of litigation if pending in any legal forum.
2. The employees being free from DAR/SPE/Vig. cases and
3. The employees being free from undergoing any penalty debaring them from promotion.

V) All the employees, who are promoted now are eligible to exercise option for fixation of pay on promotion with in one month from the date of promotion under Rule 1313 (FR.22) (1)(a)(1) of R.II.

VI)All the Supervisory officials should note that the employees under item no.4,19,22 should be allowed to take higher responsibility as LP[G] only after they pass the handling test and in procession of Competency certificate. Also, if any employee is facing DAR proceedings or undergoing any penalty, he should not be promoted.
