Sub: Selection to the post of Train Clerks in PB-1 ₹,5200-20200 with Grade Pay ₹ 1900/- against 16 2/3% LDCE Quota to be filled by Matriculate employees in GP ₹.1800 of Operating department, Secunderabad Division.

It is proposed to fill up vacancies (UR-2, SC-Nil, ST-Nil) in the category of Train Clerks in PB-1 ₹.5200-20200 with Grade Pay ₹.1900/- against 16 2/3% LDCE Quota in points staff of Operating department, Secunderabad division.

All the regular of Points staff of Operating department in pay band of ₹.5200-20200 with grade pay of ₹1800 of SC division who have completed minimum 3 years of continuous regular service in grade pay ₹ 1800 in the present category and also possessing minimum educational qualification of Matriculation or equivalent are eligible to apply for the post of Train Clerks in PB-1 ₹5200-20200 with grade pay ₹1900 against 16 2/3% LDCE quota.

It may also be ensured that:

1. all the regular employees including SC/ST who have satisfactorily completed the 2 years period of probation in the recruitment grade only need to apply.
2. CL/Substitute service rendered after conferment of temporary status before regular absorption will be counted as service for appearing in the selection for promotion to the Group 'C' post subject to satisfactory completion of the period of probation of 2 years in regular employment.

The employees selected and empanelled will have to undergo initial training course at ZRTI/MLY and their absorption as Train Clerks is subject to successful completion of the said training and also their being found fit in A-III medical classification. Applications in the prescribed proforma should be submitted duly filled in by the employees in their own hand writing and affixing a recent passport size photograph, attested by a Gazetted Officer. The selection would consist of written examination with duration of 3 hours within the following syllabus. The employees have an option to write the examination either in English or in Hindi. The employees who qualify in the written examination will become eligible for further stage of selection ie., scrutiny of service records.

Syllabus for the written examination:

- Part-'A' Questions intended to test the working knowledge in English.
- Part 'B' General standard of intelligence and proficiency through questions in Mathematics and General knowledge mainly pertaining to Railway working and matters pertaining to subjects dealt by employees in various departments.
