The University has accorded approval for grant of provisional affiliation to the following college for the academic year **2015-2016**, subject to fulfillment of the conditions and general rules of affiliation as detailed below:

The affiliation granted to the college is conditional. The University will conduct inspection of the college during November-December, 2015 for the academic year 2015-16.

**CONDITIONS:**

1. To appoint required teaching staff through duly constituted Selection Committee as per OU norms and obtain University approval for the existing and new staff for the academic year 2015-16;
  2. To upload faculty information on the University web site;
  3. To purchase books worth Rs.10,000/-;
  4. All laboratories are to be strengthened as per OU norms;
  5. Teaching diaries and Students attendance registers are to be maintained as per norms;
  6. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body;
  7. All the transactions including payment of salaries to the staff should be made through bank.
  8. Not fulfilled/Partially fulfilled conditions of OU affiliation order for 2014-15 need to be fulfilled immediately;
  9. As per APSCHE/OU norms the college should shift to its own premises as it has completed (5) academic years from the date of establishment in the leased/rented premises.
- **CANDIDATES ARE TO BE ADMITTED AS PER THE SANCTIONED INTAKE MENTIONED IN THE OU AFFILIATION ORDER AND THE ADMITTED LIST NEED TO BE SUBMITTED BY THE DATE STIPULATED TO THE DIRECTOR, DIRECTORATE OF ACADEMIC AUDIT, OU.**

From the Director of Higher Education, Lr.No.3 506/K2-1/75, dated 5-4-76.

RIDER:

Government permit the Management of South Central Railway Administration to open a Degree College at Lallaguda, in Secunderabad during the year, 1976-1977, subject to the following conditions:-

- a) The Management should run the college without any grant-in-aid from this Government either now or in future.
- b) They should obtain the affiliation from the Umanis University, and fulfil all the conditions stipulated by the University in regard to accommodation, staff, equipment, Library and play ground etc.
- c) They should collect the tuition fee as per the Government rates.
- d) They should allow fee concessions etc., to S.Cs, S.Ts and other Backward Classes as per the Rules in force, and they should also follow the rules issued by the Government from time to time in regard to reservation for S.Cs, S.Ts and other Backward Classes in respect of admissions and appointment of staff.
- e) They should open the Degree College as a separate Unit, and provide temporary accommodation immediately and permanent buildings as early as possible.
- f) The College shall open with the 1st year Degree Courses in B.A., B.Com., and B.Sc.
- g) Telugu should be the medium of instruction in the courses introduced. English medium is also permitted provided there is a minimum strength of not less than 50 qualified students per one section.
