The following are the terms and conditions which may kindly be noted.

1.	The Scheme is valid up to 01.12.2019.
2.	The retired employees should have worked Personnel Department /BZA.
3.	These who have worked as Welfare inspectors in Vijayawada Division can apply
4.	The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action (or) Under Review are not eligible for re-engagement .
5.	The re-engagement shall be strictly up to the age of 65 years or till 01.12.2019 (or) till the availability of regular candidates from RRB/Departmental selection whichever is earlier.
6.	The Maximum upper age limit of the retired employees applying for re-engagement of the post is below 65 years and no re-engaged employee should continue in service beyond 65 years of age.
7.	The Administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work /conduct is found unsatisfactory.
8.	The service of the re-engaged staff & welfare inspectors Shall be utilized till the vacancies are filled up.
9.	Monthly remuneration of a retired employee being re-engaged will be determined by reducing Pension from his/her last pay drawn (ie. Basic Pay + DA).
10.	The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
11.	Re-engagement shall be subject to prescribed medical fitness for the category in which they are re-engaged.
12.	Suitability/Competency of the applicant shall be adjudged by nominated committee before their re-engagement.
13.	The duty hours of the re-engaged employees would be as prescribed by the Competent Authority, as per the working conditions of the category.
14.	Copy of the following documents should be attached with the application. a) Service Certificate (b) Pensioner Identity Card (C) Pension Payment order.
