**I). Details showing the staff/CRS/TPTY permitted to vacate the Railway Quarters/ CRS/TPTY:**

1. **B.Gowtham Krishna, Helper ,T.No.7693, CF/CRS/TPTY** will be vacate the Railway Quarters No.87/E, North colony, Type-I and the house rent allowance and other applicable allowances will be allowed only after the date of occupation of the next allottee.

They should vacate old quarters if in occupation and advise this office. The double rent to be recovered till vacates the old Quarters. Failure of vacation of Old Quarters in time causes the suitable steps will be taken under DAR.

Rent will be recovered from the date of occupation or 8<sup>th</sup> day from the date of issue of this memorandum whichever is earlier. Rent @ Rs.132/- per month subject to revision taken place time to time as per extent rules in force and recovery of the other applicable recoveries.

Prior to occupation of the quarter the allot tee should necessarily sign in the "Quarters Register" maintained in the office of the SSE/Works (Engineering) & SSE/OPM/CRS/Tirupati.

The quarter allotted is for type employee's bonafide use of residence only. Any violation of this Clause i.e., carrying on Commercial activities in the form of Insurance Agency, Commercial Agency, Business, Trade etc., in the Railway quarters (allotted for residential purpose) would result in cancellation of allotment besides initiation of Disciplinary action under RS (D&A) Rules.
