I). Vacations:

The staff residing already in Rly Qrs should vacate the old quarters and advise this office. Double rent to be recovered till vacates the old quarters and if fails the suitable steps will be taken under DAR.

Rent will be recovered for Type-III at the rate of: **Rs.306/-** (plinth area 55.8sq.mtre) and for RVNL Type-III @ **Rs.336/-** (Plinth area 64.26 sq.mtre) per month subject to revision take place day to day as per extent rules and recovery of other applicable recoveries. Rent will be recovered from the date of occupation or 8th day from the date of issue of this memorandum whichever is earlier.

Prior to occupation of the quarter the allot tee should necessarily sign in the "Quarters Register" maintained in the office of the SE/Works (Engineering) & SSE/OPM/CRS/Tirupati.

The quarters allotted is for the employee's bonafide use of residence only. Any violation of this Clause i.e., carrying on Commercial activities in the form of Insurance Agency, Commercial Agency, Business, Trade etc., in the Railway quarters (allotted for residential purpose) would result in cancellation of allotment besides initiation of Disciplinary action under RS (D&A) Rules.
