A Tea stall contract at Aler Railway station was awarded in favour of Shri. Raghavendra Upadhyaya in the year 1969 and on death of the licensee in the year 2005, a person named K. Ramachandraiah has been running the Tea stall duly signing the contract papers from time to time up to 20.7.2013. The same has come to the notice of the administration when a complaint was received in this regard. A fact finding enquiry was conducted by DCM/SC with Shri. K. Ramachandraiah, and the allegation was found to be correct.

This incident was noticed by Vigilance Branch and have suggested that **"a data base of all contractors with contract particulars including their photos, ID proof copies such as PAN/AADHAR etc and their specimen signature can be maintained by the Divisions. The same details can be verified during grant of every extension/Renewal of the subject contract by the division"**.

In this connection, it is requested that a data base may be maintained with all the details of the contractors as suggested by Vigilance branch for improvement of the system. Action taken in this regard may be intimated to this office, so as to appraise the position to Vigilance Branch.

Based on a complaint on impersonation and running of Catering  
Contract at a station in SC division, a detailed investigation has been made.

It was noticed that the Tea stall contract was actually awarded to  
one Shri Raghavendra Upadhyaya in the year 1969. The said contractor  
died in the year 2005. But, one person by name Sri K.Racachandraiah has  
been continuing the contract as if he is Raghavendra Upadhyaya and  
signing on contract papers as Raghavendra Upadhyaya. Further, it is  
noticed that in place of Sri K.Ramachandraiah who is of 86 years of age,  
another person by name Sri K.Mohan Rao is running the tea stall at  
present. In this connection, Law branch has opined to take the possession  
of the stall since the imposter has vacated the same and necessary action  
for allotting the same to a new contractor by the Division. Accordingly,  
Division has allotted the same to the new contractor. Further, Division has  
been advised to examine if any damages can be imposed on the imposter.

To prevent recurrence of such incidents on SCR, it was suggested  
that **a data base of all contractors with contract particulars  
including their photos, ID proof copies such as PAN/AADHAR etc and  
their specimen signature can be maintained by the Divisions. The  
same details can be verified during grant of every extension/Renewal  
of the subject contract by the division.**

Since the above suggestion by Vigilance was accepted by PCCM, it  
is requested to issue the same as system improvement to all the Divisions.

The action taken in this regard may please be intimated to this  
office.
