DRM(P)/Waltair vide letter cited, has communicated the approval of Competent Authority for the Inter Railway Mutual Transfer of Sri B.Pothu Raju/Assitant workshop/MW/CRS/TPTY in pay matrix Level-1(PB Rs.5200-20200 GP.1800/-)with Sri V.NarendranathReddy(UR)T.No.1260/Asstantworkshp/Signal Mech, department/DLS/VSKP/E.Co.Rly.subject to the following terms and conditions applicable to such mutual transfers.

1. The employees will take their seniority in the new seniority unit to which they are transferred as per extant orders applicable for Mutual transfer i.e., they will retain their own seniority or take the seniority of the other in the new seniority unit to which they are posted, whichever is lower.
2. They will retain their lien in the parent Railway till such time they are absorbed in the new seniority unit on their turn.
3. They will not seek re-transfer to their parent Railway at a later date. In future if requested again, it will be treated as request transfer on bottom seniority.
4. There shall be no DAR/SPE/Vig.cases pending/contemplated against them on the date of relief.
5. They are not entitled for any transfer facilities i.e., joining time, transfer pass, composite transfer grant etc., as the Mutual Transfer is ordered at their own request.



5. They should vacate the Railway Quarters if any under their occupation and hand over the Railway Material if any under their possession to their immediate supervisor.
7. They are hereby advised that in terms of Railway-Board's letter No.E(NG)I-2006/TR/6, dated 21.4.2006, no request for backtracking from the Mutual exchange will be entertained under any circumstances.
8. The instructions contained in Railway Board's Lr.No. E(NG)I-2006/TR/16 dated 21.11.2001 may be strictly followed while relieving V.Narendranath Reddy(UR)T.No.1260/Assistant Workshop/Signal Department/DLS/VSKP with instructions to report WPO/CRS/TPTY, South Central Railway.

Sri B.Pothu Raju/Helper/MW/CRS/TPTY in pay matrix Level-1(PB Rs.5200-20200 GP.1800/-) may be relieved immediately to carry out the transfer orders first.
