**NOTIFICATION**

Sub: Re-engagement of Retired Gazetted Officers in Exigencies  
of Services in Accounts Department of S.C. Railway – Reg.

In terms of Railway Board's letters No. 2018/Trans Cell/S&T/ Contractual Staff dated 25.10.2018 and 20.12.2018, it has been decided to re-engage officers retired from Railway Accounts Department in the grade of Junior Scale/Asst. Scale and Senior Scale (not above Sr. Scale) against the **04 no. of Junior/Asst. Scale vacant posts in Hqrs. Accounts Office of South Central Railway**, as consultant in exigencies of services.

Hence, the applications in prescribed proforma enclosed herewith are invited from retired officers (JS/AS/SS level) of Railway Accounts Department so as to reach this office (Dy.CAO/G) on or before **28.05.2019** on the following terms and conditions:


1. This scheme is experimental in nature and is valid up to **24.10.2020**.
2. Retired Railway Officers of Accounts Department of above mentioned cadres can only apply.
3. The period of re-engagement is initially for one year and further extendable as per requirement.
4. Maximum age limit of the re-engagement shall be **65 years** and this limit shall not be extended.
5. The engagement of consultant shall not be considered as a case of re-employment.
6. Re-engaged officer shall be discharged immediately after joining of selected candidate(s) from UPSC or departmental selection or by transfer or on attaining the age of 65 years whichever is earlier, or on cessation of the scheme or due to surrender of post due to Man-Power planning or as per the recommendation of PHOD/CHOD concerned.
7. The Officers removed/dismissed/compulsory retired as a result of disciplinary action or in review, are not eligible for re-engagement.
8. Monthly remuneration of a retired officer being re-engaged be determined by reducing Pension-from his/her last pay drawn (i.e., Basic Pay + DA).
9. Officers retired from Senior Scale (not above Senior Scale) may be considered for re-engagement against the Junior Scale posts.
10. Monthly remuneration of a retired Senior Scale Officer being re-engaged against the Junior Scale post be determined by reducing Pension from his/her last pay drawn (i.e., Basic Pay + DA) by the officer in Junior Scale/Group 'B' just before the promotion to Senior Scale minus the pension of the retired officer. In case the last working of the retired Senior Scale Officer, re-engaged, in Junior Scale/Group 'B' post, was during VI CPC, then the corresponding amount can be worked out by applying 2.57 fitment factor and notional placement in the corresponding pay scale to ascertain corresponding VII CPC pay.

11. Suitability/Competency of the retired officer shall be adjudged before such re-engagement by a committee of three PHODs/CHODs/SAG as appointed by GM.
12. While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices.
13. 12 days leave in a calendar year on pro-rata basis is admissible.
14. Re-engaged officer shall not be entitled for perquisites such as HRA, CCA, Transport Allowance, Residential accommodation, etc. However, when required to travel in connection with official work, TA/DA admissible to regular employee working in the same Grade will be admissible.
15. The designation shall be consultant followed by (trade name) i.e., Officer appointed against the post of AFA/ADFM may be designated as Consultant (Finance).
16. Re-engaged officer will be given the responsibilities like inspections, supervision, etc.
17. Re-engaged officer will not be made in charge of the unit like Branch Officer in the Division or independent in charge in the Construction unit.
18. Re-engaged officer will not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate.
19. The consultant shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know/have the same.
20. The working hours of re-engaged officers will be same as that of the regular officers in similar posts.
21. The period of such re-engagement will not be counted as service for any purposes as admissible to regular serving officers.
22. Re-engaged officers will not be covered for any coverage under Payment of Gratuity Act or any other statutory enactments or any other extra benefits admissible to serving Railway officers.
23. Re-engaged officers will not be covered by any of the welfare schemes, C.G. appointment, ex-gratia, etc. as admissible to regular officers.
24. Re-engaged officers will not be entitled for any advances as admissible to regular officers.
