I. 
II Promotion of the employees at Para-I are provisional and is subject to the conditions that

- (b) Not undergoing any penalties &
- (c) Outcome of the pending matters/cases before courts of law/ administration

III Employees shall be given higher grade responsibility in the post of Pointsman.A with immediate effect and the same may be intimated to all concerned.

VI They are eligible to exercise option for fixation of pay on promotion under saving clause of amended Rule No.1313 (I) (a) (i) of IREC.Vol.II circulated under S.C.No.177/91 within one month from the date of promotion. Option once exercised shall be final. In case of employees fail to exercise option within the stipulated period of one month, their pay fixation will be regulated as per normal terms and conditions.
