It is proposed to conduct a selection by calling volunteers from Personnel department, fulfilling the following conditions to fill up One ex-cadre post of Vigilance Inspector/Personnel in Pay Matrix Level-6 of 7th CPC. Therefore, it is requested to give wide publicity amongst the eligible candidates about this notification and forward applications received in the proforma enclosed.

Terms and Conditions of eligibility :-

1. Volunteers should be working in Level-6 on regular basis and having lien of Personnel Department.

No. of Posts	Eligibility
One post in Pay Matrix Level -6 of 7 th CPC	Those in Level - 6 (Not MACP) of 7 th CPC

2. Staff working in Pay Matrix Level - 6 of 7th CPC on regular basis (Not MACP).
3. The volunteers should have put in minimum five years service in Railways as on the date of notification.
4. They should be free from DAR/SPE/Vigilance cases and should not have been taken up under DAR as a result of SPE/Vigilance cases during their entire period of service. They should have good record of service with proven integrity.
5. They should not have served an earlier tenure as Inspector either in the Vigilance Branch or in the Vigilance Directorate of Railway Board.
6. They should have flair for vigilance work i.e. in vigilance investigations and other associated works including putting up investigation reports.
7. Nature of work requires extensive traveling. Therefore, volunteers should be willing to work under such condition.
8. They should be working in a cadre post and not in a ex- cadre post as on date of notification.
9. Working knowledge in computers is desirable.

SELECTION:

The selection consists of a written test of three hours duration followed by a **Vigilance Aptitude & Computer Knowledge Test**. No supplementary written test will be conducted since the selection is by calling volunteers. The candidates who qualify in the written test only will be called for **Vigilance Aptitude & Computer Knowledge Test**.


The syllabus for written test will be on Establishment matters with emphasis on RS (Conduct) Rules, 1966 & RS (D&A) Rules, 1968. Volunteers are expected to have flair in carrying out investigations and preparing detailed reports. Question paper consists of descriptive questions only for a maximum of 100 marks. The selection is purely based on merit.

Though the normal tenure of Vigilance Inspector is for four years, continuance as Vigilance Inspector depends upon the individual performance and integrity. They are liable to be repatriated to their parent department at any time short of completion of tenure without assigning any reason.

Applications in the proforma enclosed should be complete in all respects duly signed by applicant and Personnel Branch officer. **All applications should be sent to this office in a sealed cover addressed to Deputy Chief Vigilance Officer (P), 3rd floor, Railnilayam, Secunderabad so as to reach by 25.12.2020 positively.** The applications received in this office after the due date will not be entertained.
