**ADDENDUM**

Sub: Selection to the post of Junior Clerk-Cum-Typist (Office Clerk) in Level-2 of 7<sup>th</sup> CPC Pay Matrix against 16 2/3% LDCE quota on NED Division.

Ref: This Office Notification issued under letter of even No. dated 22.02.2021.

\*\*\*\*\*

I. With reference to this office Notification cited under reference for selection to the post of Junior Clerk-Cum-Typist (Office Clerk) in Level-2 of 7<sup>th</sup> CPC Pay Matrix in Nanded Division of S.C. Railway against 16 2/3% LDCE quota, the eligibility condition to volunteer for selection of above mentioned post may be read as under:

- Railway servants in erstwhile Group 'D' categories for whom no regular avenue of promotion exists are eligible for promotion. Such as Office Peon of all Departments (except Account, Security & Stores Departments) and Watchman, Luscars and Compound Gangman/women attached to Civil Engineering and S&T Department.
- The employees must have minimum 02 (Two) years of continuous service in the relevant level as on the date of the issue of notification i.e. 22.02.2021 irrespective of the fact whether such employee belong to GEN/OBC/SC/ST. However, no person will be eligible to appear in the selection unless he/she has satisfactorily completed the period of probation of 02 (two) years in the recruitment grade. The period of the 02(two) years will be counted from the date of regularization.
- As per R. B. Estt/No.157/2015, for selection of Jr.Clerk-Sum-Typist against 16 2/3% LDCE quota, staff of the categories under (a) & (b) should possess the qualification 12<sup>th</sup> (+2) stage or its equivalent examination with not less than 50% marks in the aggregate a 50% marks is not to be insisted upon in case of SC/ST/Ex-servicemen.

Note:- The employees otherwise eligible as on 17.12.2014 with Pre-revised qualification i.e. Matriculation may also be considered to be eligible to the selection for promotion against the said quota irrespective of the fact whether they are GEN/OBC/SC/ST/Ex-Servicemen as per the extent procedure.

II. The employees who are in level-1/GP 1800 for whom there is regular avenue of promotion exist are not eligible selection of above mentioned post, such as Track Maintainers of Civil Engineering, Helpers of Civil Engineering, S&T, Electrical, Mechanical, Safaiwalas & Hospital Attendants of Medical, Assistant Pointsman of Operating Departments, Helper/P.way, helper/Bridges, and all other level-1 employees for whom there is regular avenue of promotion exists - are not eligible to apply.

Other terms & condition mentioned in the notification dated 22.02.2021 will remain unchanged.


