Sub:- Clarification regarding process of empanelment of advocates for High Courts, Central Administrative Tribunals and RCT Benches.

This office has been receiving queries regarding the process of empanelment of advocates for High Courts, Central Administrative Tribunals and RCT Benches. In this regard it is clarified as under:

1. There should not be any restriction with regard to experience or age of the advocate.
2. Advocate applying for empanelment should be practicing in that city and should have an office/residence in that city. No need for any forwarding certification from Bar Council or Association. Only Photocopies of the relevant certificate are sufficient which may be attached with the application.
3. The Criteria for selection would be fixed after interaction with the advocates on the basis of administrative requirements and number of cases.
4. An advocate may submit only one application for HC/CAT/RCT. His/Her option would be sought at the time of interaction. However final decision for empanelment rests with the Selection Authority.
5. The last date for acceptance of applications from advocates is 30.04.2021. Application format & E-mail address is enclosed.

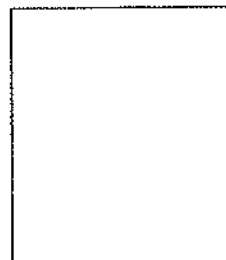
