Consequently the revised panel after including the name of Shri M.SHANMUKESHWARA RAO (SC) will be as under -

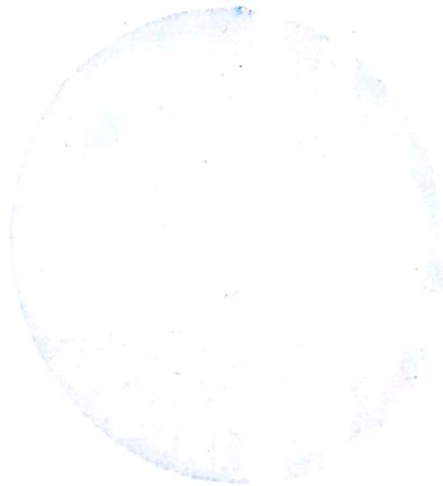
