Placement of the above officer in the higher Level 10 of VII CPC [Pay Band-3 - Rs.15600-39100 with Grade Pay Rs.5400/- of VI CPC] is subject to the following conditions:

1. The officer even after his placement in Level 10 of VII CPC [Pay Band-3 - Rs.15600-39100 with Grade Pay Rs.5400/- of VI CPC] will be classified as Group 'B' only.
2. For the purpose of promotion to Group 'A'/Jr.Scale, the placement of the above officer in the higher scale of Level-10 will not be given any weightage.
3. The above named officer whether in Level 9 of VII CPC or in Level 10 of VII CPC will be arranged in the order of his original seniority in Group 'B' for the purpose of consideration for promotion to Group 'A'/ Junior Scale or for promotion on adhoc basis to Senior scale.
4. In terms of Railway Board's letter No.E(GP) 2003/2/22 dated 12.12.2018 (RBE No.192/2018),
 - (i). on grant of Non-functional upgradation in Level-10, Pay of above Group 'B' officers, working in Level-9, shall be fixed as per provision of RS(RP) Rules, 2016.
 - (ii). Benefit of Rule 1313 I(a)(i) of R-II shall be applicable on grant of Non-functional upgradation. Date of annual increment shall be regulated by provisions of Rule 10 of RS(RP) Rules, 2016.
5. The above named officer is eligible to exercise option for fixation of pay within one month from the date of issue of this order, under Rule 1313(i) (a) of R-II.
6. The above promotion/upgradation is purely provisional and subject to revision based on the outcome of the cases pending in any courts on the above subject and subject to disposal of the cases pending if any, in respect of Writ Petitions/Appeals/Applications before the Hon'ble SC, HC and CAT.
