Grant of Financial Upgradation under the MACP Scheme in favour of the above employees is subject to:

- (a) The MACP Scheme envisages only placement in the next higher Grade Pay in the hierarchy of the revised Pay Bands and Grade Pay as per section-I, Part-A of the first schedule of the Railway services (revised pay) Rules, 2008.
- (b) The financial upgradation under the MACP is purely personal to the employees to whom it is granted and shall have no relevant to their seniority position and they shall retain their designation, status and duties.
- (c) They should be free from DAR/SPE/Vig. cases as on the date of grant of financial upgradation.
- (d) At the time of actual promotion, if any, in future ,if it happens to be in a post carrying equal grade pay than what is available under MACPS, or more grade pay than what is available on regular basis, no pay fixation would be available and only difference of Grade pay ,if due, would be made available.
- (e) The above employees are eligible for financial and certain other benefits which are linked to the pay drawn by the employee such as HBA, allotment of Government accommodation, etc.
- (f) Pay drawn in the Pay Band and the Grade Pay allowed under the MACPS shall be taken as the basis for determining the terminal benefits in respect of the retiring employees.
- (g) They are eligible to exercise option for fixation of pay on promotion under saving clause of amended Rule No.1313 (I) (a) (i) of IREC.Vol.II circulated under S.C.Nos.177/91 and 01/2020 within one month from the date of promotion. Option once exercised shall be final. In case of employees fail to exercise option within the stipulated period of one month, their pay fixation will be regulated as per normal terms and conditions.

The pay fixation on granting MACPS has been certified by Sr.DFM/BZA vide No. A/EN/BZA/E.I/03/MACP certification dt. 13.09.2021.
