**OFFICE ORDER No.100/2021 DATED 22.10.2021**

The Inter Railway request transfer of Shri. M.V.Ramakrishnan, JE(IT)/HQ's office, S.C.Railway to PFA's office, Southern Railway/MAS on bottom seniority as Junior Engineer(IT) has been approved by the competent authorities of both the railways. Accordingly, the transfer of the employee to PFA's office, Southern Railway/MAS is ordered with immediate effect:

The above transfer is subject to the following conditions:

1.	There should be no DAR/Vigilance/SPE cases pending or contemplated against him at the time of relief.
2.	As the transfer is at his own request, he will rank junior most to all the temporary/permanent JE/ITs in Level 6 of pay matrix in the new Unit to which he is transferred on the date he reports to duty
3.	The employee is not eligible for transfer incidentals as the transfer is ordered at his own request.
4.	He will not seek re-transfer to the parent Railway (i.e. S.C.Railway) at a later date under any circumstances.
5.	The staff should be relieved duly following the procedure for relief of staff as envisaged in Board's Lr.No.E(NG)I-2001/TR-16 dated 21.11.2001(RBE-229/2010).
6.	He may be relieved with instructions to report to PFA(Admin) of Southern Railway/MAS for further posting and the place of posting may be intimated on reporting to the Railway.
7.	His pay will be fixed in Level-6 of Pay Matrix as per extant orders on the subject.
8.	His administrative lien will be maintained by the parent unit till such time he is permanently absorbed in the new unit
