The following are the terms and conditions:

The hiring is temporary and valid for a period of one year from the date of hiring and further extension is subject to administrative requirements.

1. Only online applications will be entertained.
2. Applications are to be submitted through <https://forms.gle/8GsxjuHcyiq5K4Tq5> which is available on www.scr.indianrailways.gov.in - **About us – Divisions - Hyderabad Division - Notifications.**
3. Applications should be submitted by 30.10.2022. The applications received after the due date will not be accepted.
4. The Administration is at liberty to terminate the services of the hired employees even before completion of his/her term in case their work/conduct is found unsatisfactory by giving a notice of 7 days.
5. The hired retired staff should give a notice of 7 days before discontinuing his/her service on their volition.
6. The employees Removed/Dismissed/Compulsory retired as a result of their DAR action or under service review are not eligible for hiring.

7. The age and other conditions will be determined as on the date of notification.
8. The hired employees are entitled only for monthly fixed remuneration i.e reducing pension from his/her last pay drawn, (i.e Basic +DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of their retirement.
9. The hired employee will not be eligible for any kind of leave (like CL, LAP, Sick Leave etc). For absence if any, appropriate deduction will be made from their remuneration.
10. They are not entitled for any other benefit or facilities except the monthly fixed remuneration.
11. They shall execute an agreement to abide by all the terms and conditions of the hiring.
12. They should found fit to prescribed medical fitness for the relevant medical category.
13. Suitability/competency of the volunteers applicant shall be adjudged before their hiring.
14. The duty hours of the hired personnel would be supervisory and entitled for rest subject to work and requirement.
15. Copy of the following documents should be attached with the application & it is Mandatory.
(i) Service Certificate (ii) Pensioner Identity Card (iii) Pension Payment Order (iv) Aadhar card
16. While assigning the duties the safety and other operational requirements will be adequately considered.
