They are eligible for higher rate of pay from the date they shoulder higher responsibility in the new unit to which they are transferred on promotion.

They are eligible to opt for fixation of pay in promoted grade within one month from the date of issue of this order in terms of Railway Board's letter dated 13.11.1981 (PCPO/SC's S.C.No.138/1981).

In terms of PCPO/SC's S.C.No.85/2009, the employee(s) who have availed the benefit of fixation of pay in higher grade as a result of financial up gradation under MACP Scheme are not eligible for such fixation again on promotion.

The above promotions are provisional and subject to :

1. They should not be under Suspension.
2. They are free from DAR/SPE/Vig cases and from prosecution for criminal charges if any.
3. Disposal of cases if any, before the Hon'ble Supreme court/High Court/CAT as the case may be in respect of Petitions/appeals/applications pending before them.
4. The above promotions are provisional and subject to final outcome of Main SLP's and contempt petition Number (C No. 314/2016 in SLP (C) No.4831/2012-Samatha Andholan samithi through President Vs Sanjay Kothari and others) and any other cases pending in any other courts.
