II. The above employees are promoted against the existing vacancies and eligible for higher pay on promotion from the date of shouldering higher responsibilities in promoted category as Track Maintainer Gr-I.

III. In case the above employees are not willing to carry out the promotion, a written unconditional declaration to this effect should be obtained from them making it clear that the employees will not be eligible for promotion for a period of one year. If the employees not carry our the promotion within 15 days, it will be deemed to be a refusal and will be dealt accordingly as per the instructions under PCPO/SC's letter NO.P/R/585/VI, dated 29.04.2006 and No. P/R605/II dt 07.01.2008.

The above promotion order is subject to the following terms and conditions:

1. The employees who were already granted financial up gradation in GP:2800/Level-5 under MACP scheme, are not eligible to opt for fixation of pay in promoted grade. 2 .The employee who were not granted MACP are eligible to opt fixation of pay in promotion grade within one month from the date of shouldering higher responsibilities in terms of PCPO/SC No.138/1981 & 107/2017. 3. The Supervisor should ensure before promotion is effected by the employee that they are not under suspension ad free from DAR/SPE/VIG. cases and not undergoing any penalty affecting promotion. 4 . The above promotion order is provisional and subject to disposal of cases, if any in Supreme Court/High Court/CAT etc. as the case may be in respect of writ petitions/appeals/applications respectively pending before them. The above promotions shall be subject to the outcome of the main SLPs and Contempt Petition (C) No.314/2016 in SLP (C) No.4831/2012 - Samta Andolan Samiti through President Vs. Sanjay Kothari & Others and any other cases pending any other courts on the above subject. The above promotions are "PROVISIONAL" subject to final outcome in SLP [C] No.30621 of 2011 (PCPO/SC's instructions vide Lr. No. SCR/P-HQ/602/RP/Policy dt 16.06.2021). The above promotions are also subject to revision based on the final outcome of the above court cases and any other cases/directions issued from time to time. The date on which the promotions are effected should be intimated to all concerned. This issues with the approval of competent authority.
