**OFFICE ORDER No.63/2023 Dated: 13.06.2023**

A.Arthy D/o A.Satyanarayana Goud, a candidate selected for appointment as Temporary Accounts Clerk by Railway Recruitment Board under OBC Quota, having been declared medically fit for the post of Accounts Clerk by Medical Director/S.C.Railway/Lallaguda vide Medical Certificate No.401/20.03.2023 dated:20.03.2023 in VH Quota, is appointed as Temporary Accounts Clerk in Level-2 at pay Rs.19,900, GP-1900/- with usual allowances and posted to the office of PFA/CN/SC subject to following conditions.

- 1) She is eligible to draw pay and allowances as admissible from time to time from the date he reports for duty.
- 2) Her appointment is purely temporary for the first two years and he will be on probation and as long as he is retained in service for all purposes, be treated as belonging to HQRS clerical Seniority Unit. He will be assigned the seniority as per the merit order given by RRB.
- 3) She will have to undergo training/refresher course as required by the Administration from time to time.
- 4) The above candidate should open his/her savings account in a Bank within 10 days from the date of appointment at the place of his/her Posting to facilitate the drawing of wages, if not already having a Bank account.
- 5) She shall be governed by all other rules and regulations for Railway employees from time to time. He comes under the purview of National Pension System as Laid down in the Railway Board's Guidelines issued from time to time.
- 6) She will not be entitled to any notice of termination of service or pay in lieu thereof, if such termination is due to expiry of sanction of the post which he holds or on expiry of the officiating vacancy or is due to mental or physical incapacity or to his removal or dismissal as a disciplinary measure after compliance of clause (2) of Article 311 of the Constitution of India, otherwise, his service will be terminated on one month notice on either side or pay in lieu thereof.

- 7) She is also liable, if so required, for Military Service in the Railway Engineering units of the Territorial Army for a period of seven years and eight years in the Territorial Army Reserve or for such period as may be laid down in this behalf from time to time.
- 8) Her appointment is provisional subject to verification of all the relevant certificates, if it reveals that he has produced false certificate, his services will be terminated forthwith without assigning any further reasons/notice and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for submission of false caste/other certificates.
- 9) Her services may be dispensed with, without assigning any reason or notice, if his performance is not found satisfactory.
- 10) In case any information furnished by the candidates were found false, their candidature to the said post is liable to be terminated without any further notice.
- 11) She is appointed under PwBD quota and has been exempted from CBTST and provisionally empanelled vide Board's letter No.2012/E/(RRB) dated 25.09.2012. However, he is required to pass Typewriting proficiency Test of 30 W.P.M in English or 25 W.P.M. in Hindi within a period of 2 years from the date of appointment in terms of Railway Board letter E/NG/94-RC-1/85 dated 25.05.1994.
