Notes:

1. If a particular post as mentioned in the Table above is vacant/not available, CPM/GS shall approach PHOD of concerned Department through DRM to nominate alternate officer.
2. If a particular officer of Sister/Finance department is of higher grade than the Accepting Authority i.e. DRM, CPM/GS shall approach PHOD of concerned Department through DRM to nominate alternate officer to associate as member of Sister / Finance Department.
3. * DRM shall decide the sister department member based on the following guidelines:
 - (a) CPM/GS or the member from the sister department shall have the necessary technical expertise of the subject tendered work.
 - (b) If CPM/GS is having the technical expertise of the subject tender work, third member (sister department) shall be decided based on the nature of work involved.
 - (c) In no case CPM/GS (the Convener) and Sister Department shall be of the same department.
5. DRM will be exercising the same powers as that of CAO(C) for works of Gati Shakti Units in Division.
