**Procedure of Re-engagement:**

Volunteering eligible retired employees will be called for document verification and screening by the Competent Authority. If found suitable for re-engagement in all respects, such shortlisted candidates shall be sent for medical examination in appropriate medical category

**General Conditions.**

1. The employees Removed /Dismissed/Compulsory retired as a result of D&AR action of under review are not eligible for re-engagement. Further employees retired under safety related retirement scheme (SRRS)/LARSGESS are not eligible.
2. Re-engagement is purely on temporary basis and re-engaged retired staff will be terminated as and when suitable regular incumbents join the post either by way of recruitment or by transfer or on attaining the age of 65 whichever is earlier, on cessation of the scheme or due to surrender of post due to Man Power Planning.
3. The re- engaged employees are entitled only for monthly fixed remuneration i.e reducing pension from his/her last pay drawn, (i.e Basic + DA) at the time of retirement . The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement
4. The re-engaged employee will not be eligible for any kind of leave (like CL, LAP, Sick Leave etc.,). For absence if any, appropriate deduction from salary/wages will be made from the monthly remuneration.
5. In case of absence of duty, proportionate amount of remuneration per day will be deducted.
6. The re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.
7. Re- engagement shall be subject to prescribed medical fitness for the relevant category.
8. Suitability /Competency of the applicant shall be adjudged by nominated committee by the way of personal interview before their re-engagement.
9. Such re-engaged retired railway staff can be terminated after giving a notice period of one month
10. The TA/DA shall be payable as per extant rules
11. Re-engaged retired staff will not have the right for continuity/extension of re-engagement
12. The re-engagement is subject to the orders issued by Railway Board from time to time
