GENERAL CONDITIONS :

1. Before applying for the post, the retired employees should ensure that he/she fulfils all the eligibility norms.
2. Retired employees applying for the post should not have been covered under the safety related retirement scheme (SRRS/LARSGESS).
3. Their engagement is subject to medical fitness in the appropriate category.
4. Suitability/Competency of the retired employee will be adjudged before engagement while processing the selection.
5. The maximum age limit of the retired employees applying for the post is below 62 years and in no case should exceed the maximum of 62 years during the period of re-engagement.
6. The daily remuneration shall be paid in terms of Railway Board guidelines issued under their letter No. E(NG)11/2007/RC-04/CORE/1 dated 11.12.2009, with the concurrence of Finance Directorate of Ministry of Railways as detailed below :

For re-engagement in PB+1 with Grade Pay ₹2800	₹320 per day
For re-engagement in PB+1 with Grade Pay ₹2000	₹320 per day

7. On Re-engagement of retired employees the daily allowance (remuneration per day) and Basic Pension should not exceed the last pay drawn.
8. The selection is subject to their being found suitable by the committee constituted for the purpose.
9. Remuneration will be as per the Grade Pay to which the retired employees are re-engaged.
10. The Administration is at liberty to terminate their services in case they are found unsatisfactory, without prior notice and they will not have the prescriptive right for continuity in service on daily wages beyond 62 years of age.
11. The engagement of retired employees will be subject to discharge of engaged staff immediately on joining of selected candidates from DRQ/Promotional Quota.
12. Photocopies of documents to be attached:
 - i. Service Certificate.
 - ii. Pension Payment Order.
 - iii. RELHS card (If available).
13. The scheme will be valid up to 14.09.2013 only.
