

- They have passed the mandatory promotional training and completed practical handling
 - They have completed two years of service as Sr.ALP/ALP.
 - They have 60,000 Kms experience on foot-plate.
 - They are fit to handle Locomotives independently alongwith other requisite conditions as prescribed by Board.

2. The following conditions should be fulfilled before utilising them as Loco Pilot (Goods):-
- (i) Such promoted Loco Pilots should be placed under the supervision of dedicated Loco-Inspector for 5 trips or 500 Kms of driving whichever is earlier.
 - (ii) For Sections classified as "Ghats" such promotee Loco Pilots may work with a regular Loco Pilot as "Co-Loco Pilot" for Seven days or 1000Kms of driving whichever is later.
 - (iii) Provision of hands on training for independent Loco Driving to Diesel /Elect Assistants in thier induction and refresher courses shall be included in the course for the promotional trainings.
3. There are no DAR/SPE/Vig. Cases pending against all the above employees and they are not undergoing any punishments debarring them from promotion and they are not under suspension at the time of transfer/promotion.
4. Outcome of the main SLPs and Contempt Petition (C)No.314/2016 in SLP (C) No.4831/2012 filed by Samta Andolan Samiti through its President Vs Sanjay Kothari & Ors pending before Hon'ble Supreme Court and any other cases peding in any other courts.
5. They should be medically fit in A-1 (AYE ONE) to hold the post of Loco Pilot(Goods).
6. They are also eligible to exercise option for fixation of pay on promotion under Rule 1313 (FR22) I (a) (i)- R-II (for fixation of pay) in the promotional grade within one month from the date of effecting the promotion in terms of SC No.138/81 read with S.C.No.107/2017.
7. The employees who are under orders of transfer on promotion should be relieved within 15 days from the date of issue of office order. The controlling officer/supervisor in-charge shall be held responsible for not relieving the employees within the stipulated period in terms of Railway Board's Lt.No.E (NG) I-9/PM1/19 dated 01.08.1995 circulated under S C No.127/95 & 139/97.
8. If any of the above employees are not willing to carry-out the transfer on promotion, a written declaration to that effect shall be obtained and forwarded to this office within a fortnight. If no intimation is received by that time, it will be deemed that the employee is not interested in effecting the promotion and accordingly he will be debarred for promotion for a period of one year in terms of instructions contained in Para No.224 (II) , chapter-2 of IREM-I, and dealt with accordingly.
9. For retention of railway quarters, if any under their occupation, controlling officer's specific permission should be obtained in writing. Retention of railway quarters without permission will be treated as unauthorised occupation and they shall be liable for recovery of damage rent.
10. The supervisor in-charge shall advise the supervisor of the new unit to which the employee has been transferred of the following details in respect of the employee.
- a) Casual Leave account for the calender year;
 - b) Next date of periodical medical examination; and

c) The date on which the employee has to attend the refresher course.

11. The supervisor in-charge taking the employees on roll on transfer shall indicate the following details with muster rolls.

- a) Date of joining; and
- b) Office order number & previous station of posting.


12. The employees who have been issued with the railway materials should return the same to the supervisor incharge. In case if they fail to do so the supervisor incharge shall advise the list of the items with their cost to the controlling officer and Sr.DPO/SC for their recoveries from the employees.

13. The employees who are under orders of transfer on promotion are eligible for transfer benefits/facilities as per the extant rules.

14. Copies of the shouldering higher responsibilities of the post of Loco Pilot (Goods) of the above named employees should be forwarded to this office to enable to issue pay-fixation memorandum on promotion.

This issues with the approval of the competent authority.


