NOTIFICATION

Sub : Proposal for re-engagement of retired railway staff on daily remuneration basis on SC division.

Ref : Railway Board letter No. E(NG)/11/2007/RC-4/CORE/1 dt.16.10.17.

In terms of Railway Board's letter No. E(NG)/11/2007/RC-4/CORE/1 dt.16.10.17, it has been decided to invite applications from able and eligible retired staff for the following posts for the stations indicated below on daily remuneration basis. The details of the Department & post wise requirement is as under:

Sl. No.	Department	Post/ Category	7 th PC Level
1.	Commercial	ECRC	L-5 L-6

The applications should be addressed to respective APOs and the same should reach within 15 days from the date of notification. It should be sent in person or by ordinary post.

The re-engagement of staff shall be on the following terms and conditions:

1. Only retired railway employees of SECUNDERABAD Division are eligible to apply.
2. The scheme is valid upto 01.12.19.
3. The retired employee should have passed SSC or equivalent (requisite qualification for the required post).
4. The staff retired from railway service can only apply.
5. The employees removed/dismissed/compulsory retired as a result of DAR action or under review are not eligible for re-engagement. Further employees retired under Safety Related Retirement Scheme(SRRS)/LARSGESS are not eligible.
6. The re-engagement shall be strictly upto the age of 65 years on or before 01.12.19 (or) till the availability of regular candidates from RRB/RRC/departmental selection, whichever is earlier.
7. The maximum upper age limit of the retired employees applying for re-engagement of the post is below 65 years and in no re-engagement employee should continue in service beyond 65 years of age.
8. The administration is at liberty to terminate the services of the re-engaged employee even before 01.12.2019 in case their work/conduct is found unsatisfactory.
9. While assigning the duties the safety and other operational requirements will be adequately considered.

10. Monthly remuneration of a retired employee being re-engaged will be determined by reducing pension from his/her last pay drawn (i.e. Basic Pay + DA).
11. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
12. Re-engagement shall be subject to prescribed medical fitness for the category in which they are re-engaged.
13. Suitability/competency of the applicant shall be adjudged by nominated committee before their re-engagement.
14. The duty hours of the re-engaged employee would be prescribed by the competent authority, as per the working conditions of the category.
15. Copy of the following document should be enclosed with the application.
 - (i) Service Certificate.
 - (ii) Pensioner Identity Card.
 - (iii) PPO.
16. TA/DA as applicable.
17. The place of posting shall be based on preference given by the retired employees and availability of vacancy at the place.
