The posting of the above named employees as Crew Controllers and Chief Crew Controllers is subject to the following conditions:

- The tenure for the post of CC/CCC is 3 years with a cooling off period of equal duration;
- Their lien will be maintained in the parent cadre from where they are drafted. They will continue to progress in the running cadre and will be governed by all the qualifications, terms and conditions of the service applicable to the running staff including pay and allowance, selection suitability test and periodical medical examinations etc.;
- They are eligible for payment of allowance in lieu of kilometrage per day at the rates applicable to them from time to time;
- They are not eligible to claim TA/DA and Special Pay;
- There are no DAR/SPE/Vig. cases pending/contemplated against them; and
- If the performance of the above said employees is found to be unsatisfactory, they are liable to be repatriated to their parent cadre without assigning any reasons for such repatriation.

The date on which the above change takes place along with the date of joining in the post should be intimated to this office.
