The above panel is provisional and subject to the following conditions:-

- 1) They should be free from DAR, SPE and Vigilance cases and not under suspension.
- 2) Outcome of any court cases relating to the above selection pending in any judicial forum of any Appeal/Writ/SLP in regard to reservation policy.
- 3) Subject to outcome of Contempt Petition @No.314/2016 in SLP @ No.4831/2012-Samta Andolan samiti through President Vs Sanjay Kothari & Ors.
- 4) In terms of Board No.2018E(SCT)/25/9 dated 28-12-2018, in view of the judgement in Jarnail Singh & others Vs Lachhmi Narain Gupta and others : SLP(Civil)No.30621 of 2011 dated 26-09-2018, these orders are provisional and are subject to the final outcome of ongoing litigations/Court cases on the subject.
- 5) The promotion of the employees shall be subject to further orders which may be passed by the Hon'ble Supreme Court.
- 5) Their promotion and posting as Station Master is subject to their successful completion of initial training course prescribed for the post of Station Master at ZRTI/MLY.
