


Since the medical classification prescribed for the post of HelperMech/C&W (Revised designation Assistant/Mech/C&W) is B-1 and that for Trackman is also B-1 the employees fulfils the medical requirement.

**The above short- listed is provisional subject to the following condition:**

- 1) The employee should be free from DAR/SPE/Vig cases.
- 2) The employee should accept that half of the length of continuous service which qualifies for determining his seniority in Track Maintainer category will only be counted for the purpose of seniority on his transfer/induction to the post for which he volunteered against 10% Lateral Induction quota, interms RBE.No.146/2018, PCPO/SC's S.C.No.174/2018.
- 3) The employee should be willing to work at any station on SC division in the event of his induction to the post for which he volunteered.
- 4) Induction of the shortlisted employees to the posts for which they have volunteered will be subject to their qualifying in the initial training course, wherever prescribed.
- 5) As the transfers are ordered at their own request they are not entitled to any transfer benefits.
- 6) Their application for Inter Railway/Divisional Transfer in Engineering dept., as Track Maintainer is treated as cancelled, since they have opted for induction to Mech/C&W department.
- 7) They will not seek re-transfer to their parent cadre at a later date.
- 8) Outcome of judgment of Supreme Court/High court/CAT the case may be in respect of Writ Appeals/Petitions/Applications, if any pending before them.
