The Hon'ble CAT/HYB, in their interim direction, has ordered on 10.06.2019 in OA No.501/2019 that the applicant is permitted to appear in the written examination and the outcome of the selection is subject to the outcome of OA. Hence it is recommended to keep one vacancy aside. As and when the Hon'ble CAT/HYB delivers final orders, necessary action will be taken for filling up the vacancy.
- As per the Railway Board's directions dated 30.09.2016 (S.C.No.104/16) and 19.06.2019 (S.C.No.121/2018) the employees of reserved community are booked against reserved vacancies. However, the panel is provisional and subject to outcome of ongoing litigations/Court case including SLP 30621/2011 and 31288/2017 pending before Hon'ble Supreme Court of India.
