EXPRESSION OF INTEREST

Chief Medical Superintendent, Secunderabad Division of South Central Railway is looking for Health Care providers across the division to provide comprehensive emergency care to their beneficiaries at BIDAR, PRLI, KARIMNAGAR, MANCHERIAL, WARANGAL/ HANAMKONDA and KHAMMAM of Secunderabad Division on credit basis at CGHS 2014 (Hyderabad City rates) rates or otherwise.

1. LOCATION:

The Health care providers should be located at the following places.

- a) **BIDAR** (for Railway beneficiaries of HU/VKB).
- b) **PARLI** (for Railway beneficiaries of HU/PRLI).
- c) **KARIMNAGAR** (for Railway beneficiaries of HU/RDM).
- d) **MANCHERIAL** (for Railway beneficiaries of HU/BPA).
- e) **WARANGAL/ HANAMKONDA** (for Railway beneficiaries of PC/KZJ & HU/DSL/KZJ).
- f) **KHAMMAM** (for Railway beneficiaries of HU/DKJ & HU/BDCR).

2. TERMS AND CONDITIONS:

- a) The validity of empanelment is for two years, further extension may be done with mutual consent of both parties.
- b) The empanelment is subject to certification by inspection team of doctors from Secunderabad Division, South Central Railway and acceptance by Competent Authority.
- c) Decision of Competent Authority is final.
- d) The Health Care Providers should accept the terms and conditions stipulated by Railways from time to time.

3. RATES AND SERVICES:

- a) CGHS 2014 tariff(Hyderabad City rates) with 10% rebate.
- b) Those investigations/procedures/packages which are not listed under CGHS 2014, will be billed as per empaneled hospital tariff with 25% discount.
- c) The interested hospital/s should mention whether it is NABH accredited hospital or Non-NABH hospital (National Board for Accreditation of Hospitals).
- d) 10% discount on medicines.
- e) Free ambulance services should be provided by empaneled hospitals for transport of Railway beneficiaries.
- f) Those hospitals which have submitted their willingness (EOI) will be inspected by a team of Railway Doctors to see the facilities and recommendation for empanelment.
- g) The Health care providers should respond within 365 days from the publication of this advertisement.
