

- II. **Communication:** Communication with candidates will be done through SMS, WhatsApp message, telephonic call and through website of SCR. Candidates are advised to keep visiting the official website of SCR regularly for updates.
- III. After scrutiny of the application received, the same will be shortlisted by the nominated committee based on the Educational Qualification, experience and other relevant factors. Shortlisted candidates will be interviewed through Whatsapp video call.
- IV. **Terms and Conditions:**
  1. The vacancy position may increase/ decrease as per administrative necessity. There may be wait listed/stand by candidates who may be engaged in order of merit when there is necessity.
  2. The selected candidates have to work in COVID wards

3. **Experience:** Candidates applying for the post of Specialist Doctors (Pediatrician) should possess experience of working. Candidates while applying should indicate past service rendered, if any including the period of contract put in by them on Indian Railways.
4. As the engagement is done on a temporary measure, the rules regarding communal reservation shall not be applicable.
5. Engagement on Contract basis of the candidates will be subject to their being found suitable in order of merit by Selection Committee. The candidates selected will be placed on panel and will be sent for Medical Test as per rules.
6. The decision of the office of undersigned in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, selection, allotment of posts selected candidates will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection. Candidates who submit fake certificates for securing eligibility, shall be liable for rejection of his/ her candidature for the post for which he /she has applied besides being taken up as per common law for attempt to forgery
7. The candidates selected will not have any claim or right for his/ her continuity in service or automatic extension of the term of contract services or will not have any right in respect of considering of their contract period in case of their regular selection, if any, in Railways in future, nor will it confer any right for regularization or absorption in Railway service. The contract can be terminated by giving 15 days notice on both the sides. Railway administration reserves the right to terminate the contract at any time during the contract on or before 31.03.2022 by giving 15 days notice or payment of 15 days remuneration without assigning any reason therefor.
