
PENSION ADALAT – 2021

It may be noted that the Pension Adalat is for the purpose of redressing the grievances of pensioners regarding non-payment of settlement dues and pension etc. Hence grievances not connected to settlement dues and cases involving purely legal points e.g. succession certificate etc. cannot be taken up in the Pension Adalat. Grievance once redressed through earlier Pension Adalats, need not be represented again.
- 5) Last date for receipt of Grievances to the respective officers is 15.11.2021.
