**NOTIFICATION**

Sub: Re-engagement of Retired State Government officials from Revenue/Forest Departments on contract basis in exigencies of services in projects where land acquisition is involved.

Ref: Railway Board's letter No.E(NG)II/2020/RC-4/2(Pt.2) dated 22.02.2022.

In view of the exigencies of railway services, it has been decided to re-engage retired State Government officials from Revenue/Forest Departments on contract basis for work related to Survey, updation of land records, coordination with State Government agencies for forest/wild life clearances in railway projects where land acquisition is involved;

“Railway Projects under Chief Administrative Officer/Construction/SCR and important railway infrastructure projects over South Central Railway”.

1. For filling up of 07 positions of Consultant (Land Acquisition) on re-engagement basis, applications are invited from experienced and motivated retired State Government officers, who have worked as Additional Tahsildar/ Tahsildar/ MRO/VRO/Surveyor/ Assistant Collector /Deputy Collector/LAO/Spl LAO, Asst. Conservator of Forest, Divisional Forest Officer/Ranger etc. in Government of Telangana/Andhra Pradesh/Maharashtra State. The retired Government officials with experience in land acquisition/land survey work would be given preference.
2. The vacancy notice is at Annexure-I. Eligible and interested retired officers may apply as per the application format at Annexure-II. The duly filled in application should be sent to the **Senior Personnel Officer (Engg), office of The Principal Chief Personnel Officer, IV Floor, Rail Nilayam, Secunderabad - 500071 in an envelope. The envelope should be super scribed with “Application for the position of Consultant (Land Acquisition).**
3. The candidates will be screened by a Selection Committee and their suitability will be adjudged keeping in view the job requirements/service particular/relevant work experience etc.
4. i) A fixed monthly amount will be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed will remain unchanged for the term of contract.  
ii) No increment, Dearness Allowance and HRA or any other allowance will be allowed during the term of contract, except as mentioned in the notification.  
iii) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work will be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, they may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.

**5. TERMS AND CONDITIONS:**


- i) Suitability/competency of the staff shall be adjudged before such re-engagement.
- ii) Maximum age limit for such re-engagement shall be 65 years. No such re-engaged staff will continue in service beyond 65 years of age in terms of extant rules
- iii) The integrity clearance will be taken while permitting such re-engagement, as feasible.
- iv) Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of service.
- v) The employees who were removed/dismissed or compulsory retired as a result of Disciplinary action are not eligible for re-engagement.
- vi) The re-engaged officials will not be eligible for any kind of leave (like CL, RH, LAP, Sick leave etc).
- vii) The re-engaged retired officials shall sign an agreement of confidentiality with the Railway containing a clause on Ethics and Integrity.
- viii) The re-engagement can be terminated without any notice and without any explanation or any reason.
- ix) The period of contract will be up to 21.02.2023.
